Direct Support Organizations (DSO) Committee Minutes Trustee Thomas Dortch, Chair Thursday, June 2, 2022

Chair Thomas Dortch, Jr. called the meeting to order. Trustees Kristin Harper, Kelvin Lawson, and Kenward Stone were present. A quorum was established. Three action items and several informational items were presented to the DSO Committee.

Approval of February 16, 2022, DSO Committee Meeting Minutes

Trustee Lawson motioned for approval; seconded by Trustee Harper. The motion passed, unanimously.

<u>Consideration of Approval of FY 2021-2022 Foundation Operating Budget</u> <u>Amendment - \$73,000 - Foundation Board Support</u>

The FY 2021-2022 Foundation Operating Budget Amendment for \$73,000 for Board Support was submitted for approval in accordance with FAMU Board of Trustees Policy Number 2018-01. The Foundation Board approved, in advance, the operating budget amendment. A motion was made to recommend the budget amendment to the FAMU BOT for approval. Trustee Harper motioned for approval; seconded by Trustee Lawson. The motion passed, unanimously.

Consideration of Approval of DSO Budgets: FY 2022-2023

The FY 2022-2023 DSO Budgets for the FAMU Foundation and Rattler Boosters were submitted for approval in accordance with FAMU Board of Trustees Policy Number 2018-01. The FY 2022-2023 budget for the FAMU National Alumni Association (NAA) will be presented at the next DSO Committee meeting, since their Executive Board was scheduled to approve the budget on today, June 2nd.

The Budgets for the Foundation and Rattler Boosters were approved in advance by their governing boards. A motion was made to recommend the DSO Budgets to the FAMU BOT for approval. Trustee Lawson motioned for approval; seconded by Trustee Harper. The motion passed, unanimously.

Shawnta Friday-Stroud, Ph.D., provided updates on Divisional Activities A. FY 2021-22 University Advancement

- FY 2021-2022 Fundraising Progress as of May 23, 2022:
 - Raised over \$23.13M (172% of \$12.2M Goal)
 - New Cash Goal \$8.25MCurrently over \$20.2M
- Dr. Friday-Stroud noted that there were significant increases in corporate giving which was attributed to enhanced engagement from corporations whose missions include a renewed focus on diversity, equity, and inclusion initiatives, as well as in



planned giving which was ascribed to an increase in legacy giving from life insurance and wills.

- The 3rd Annual 1887 Strikes Day of Giving was held on April 21-22, 2022. The University raised over \$660,000.
- The Oral History Project has produced the following results:
 - o Respondents 5,347 in May, 4,431 in April
 - o Stories 4.012 in May, 3,352 in April
 - o Donations 662 in May, 529 in April

B. DSO Update

1. FAMU Foundation

- The Foundation Board is holding its Spring 2022 Board of Directors Meeting on campus, June 1-3, 2022.
- Investment Value \$159,758,620 as of March 31, 2022, compared to \$156,390,481 as of September 30, 2021.
- Endowment Value \$122,192,828 as of March 31, 2022, compared to \$115,184,438 as of September 30, 2021.
- There will be a Capital Campaign Board Training at the August 2022 FAMU BOT Retreat conducted by Alexander Haas Consulting Group.

2. FAMU National Alumni Association (NAA)

- The FAMU NAA is holding its 2022 National Convention on campus, June 1-5, 2022.
- Congratulations to incoming NAA President, Mr. Curtis Johnson. He will start his administration on July 1st.
- Outgoing NAA President, Col. Gregory Clark was thanked for his outstanding service.

3. FAMU Rattler Boosters

- Rattler Boosters President, Mr. Selvin Cobb and Vice President, Col. Ronald M. Joe provided a brief presentation to the Committee requesting that the committee consider reviewing the allowance of the Rattler Boosters to open a checking account for operational expenses.
- After discussion, the Committee recommended approval of the following item to be moved from an Informational Item to an Action Item:
 - Amend Section 2 of BOT Policy 2005-18 with a corresponding MOU to allow the Boosters to open an outside operational checking account.
 - Motioned by Trustee Lawson
 - Seconded by Trustee Harper
 - The motion passed unanimously.

Biographical Summary¹

[Dr.] Walker holds a bachelor's degree in accounting from the University of Houston, an MBA from the University of St. Thomas in Houston, and a doctoral degree in higher education administration from Northeastern University, Boston.

She comes to FAMU with more than two decades of executive leadership in higher education. Prior to her tenure in New Orleans, Walker was vice president for finance and administration at Cowley College in Kansas. She was previously executive vice president and chief operating officer at Texas Southern University in Houston, where she helped that Historically Black College and University (HBCU) navigate financial turbulence. Walker also worked as executive vice chancellor for finance and administration and CFO at Houston Community College. Her first vice presidency was at what is now South Florida State College in Avon Park, Florida.

Walker said joining FAMU offers the opportunity to work at a higher education institution that is serious about "student excellence."

"I have admired FAMU's commitment to student success for a long time, and since I share that commitment, that makes it the best place for me to continue my career. FAMU has been on my bucket list for a while," said Walker, who hopes to earn the trust and confidence of faculty, staff, and students to assist the University and its leadership team in achieving its goals, one of which is to become one of the U.S. News & World Report Top 100 National Public Universities in the country.

"We will be able to do that by continuing the University's commitment to student success-students who are successful in reaching their goals," she added. "I am about students being successful. If students are successful and have a great experience with the University, then the finances will grow, the University will attract more students and will increase its alumni and philanthropic giving."

1. FAMU Foundation, Inc.

- FAMU Foundation Fall 2022 Board of Directors Meeting will be held on November 16-19, 2022, in Orlando, FL., in conjunction with the Florida Classic.
- A FAMU Foundation Board Meeting & Retreat was held on Sunday, September 4th, in Fort Lauderdale, FL, in conjunction with the Orange Blossom Classic.
- The Investment Portfolio balance as of July 31, 2022, is \$150,942,911.
- The Endowment balance as of July 31, 2022, is \$111,817,447.



2. FAMU National Alumni Association (NAA)

• FAMU NAA Student Scholarship Dollars Vote

- Newly installed FAMU NAA President Curtis Johnson, Jr. and the Executive board were joined by several alumni chapters in voting August 30th to transition more than \$300K in student scholarships to our alma mater.
- These dollars will help students across the board from incoming freshman to rising seniors. The funds have already cleared the FAMU Foundation and are headed to the accounts of many students.

• OBC Legislative Breakfast and Symposium

- Although the dark clouds yielded a tough loss for our Rattlers on the gridiron; the Orange Blossom Classic was still filled with alumni fellowship and meaningful events; The FAMU NAA and JSU Alumni Association were proud to host the OBC Legislative Symposium featuring our own FAMU President Dr. Larry Robinson, JSU President, Attorney Thomas Hudson, lawmakers from the Mississippi State delegation and Florida Conference of Black State Legislators.
- The Event's focus was to Engage, Empower and Elevate as we examine the scope of issues, challenges, and solutions toward the sustainability and survival of our HBCUS.

3. FAMU Rattler Boosters

- Selected Truist Bank as the financial institution for the Rattler Boosters' Operational account.
- Completed the Football video upgrade project total cost of \$22,000.
- Held the Rattler Boosters' Virtual Volleyball and Football Kickoff Fundraiser on August 23rd; As of September 20th, over \$30,000 has been raised.
- Working with the University Division of Audit to complete the Crowe DSO Corrective Action Plan (CAP).
