The Americans with Disabilities Act (ADA) ensures civil rights protection for individuals with disabilities, parallel to those established for women and minorities. It prohibits discrimination based on disability and mandates accessibility in public accommodations and facilities.

## FAMU Reporting Options for the ADA

At Florida A&M University (FAMU), the Office of Equal Opportunity Programs (EOP) oversees ADA compliance through the ADA Coordinator, Montell Holmes. If you encounter discrimination or barriers due to your disability, you have reporting options available:

- File a complaint with the Office of Equal Opportunity Programs.

#### Retaliation

Retaliation against individuals who exercise their rights under the ADA is strictly prohibited. FAMU upholds a zero-tolerance policy against any form of retaliation. If you experience retaliation for asserting your ADA rights, report it immediately to the ADA Coordinator or the Office of Equal Opportunity Programs
