#### Ms. Thurman:

- **A&S Report**s were provided to Senator Noble
- How many suits and dresses per person on the royal court? Men receive 3 suits and a rental tux. King of Orange and Green and Mr FAMU received one extra suit to attend an additional event, Ladies received a total of six outfits, and alternate outfits were purchased independently
- How much does each outfit cost? Outfits are typically \$80 or less per person for women, and every mens set of suits are \$5000
- The vendor for the royal court outfits includes tailoring
- Does the Royal court receive any additional funding outside of A&S? This year the Royal Court is pending additional funds from events and partnerships Mr. and Ms. FAMU attended.
- Is there a list or record for the events and programming? There have been 7 events, and 2 upcoming events. Programming is separate, depending on the training necessary per person.
- Which members have not fulfilled their events? Graduate attendant (Event coming up), King of Orange and Green (Event was blessing and brunch, but this does not count as blessings and brunch was not a platform point), and Freshman attendant has not fulfilled her event.

#### - Chairman Strappy requests word for word report of interactions with Vice- President Francis

- Ms. Mary is called on the phone by Vice President Francis:
- Ms. Mary emphasizes that Vice-President Francis is not responsible for the lack of a complete homecoming report as he is a student, and students do not have access to the system.
- Chairman Strappy: To reiterate, are you not the Homecoming Steering Committee chairperson?
- VP Francis: Yes
- Chairman Strappy: So, that's in your duties, correct?
- VP Francis: Right, but how can I give you a report, when I don't have access myself.
- Ms. Mary again emphasizes that VP Francis is a student who does not have access to the University processing.
- Chairman Strappy: Emphasizes that senators cannot go and get A&S reports, so they rely on financial custodians, which for VP Francis, is Ms. Mary
- VP Francis: She just said that the reports are processing
- Chairman Strappy: Regarding the meeting minutes and the committee minutes and your memorandum to appoint these sub-committees, where did you put them? And where are they right now?
- VP Francis: They are at my house
- Chairman Strappy: So, do you have them?
- VP Francis: Yeah
- Chairman Strappy: and are they on file or oh your computer>
- VP Francis: On my computer
