- Shall there be a student elected Treasurer? 1st
- Should the SGA implement recreational Fees?

- Conversation about adding a referendum to add the questions to the Spring 2024 ballot.
- Acting chairwoman Scott moved to add a referendum asking should there be a student elected Treasurer added to the Spring 2024 ballot, seconded by Chairman Strappy

- Senator McClover moved to have a pro/con debate regarding question 3
- Pro: If implemented, more money will be available for funding agencies
- Con: tuition increases are not favorable
- Pro: The money could be reallocated to different entities, by taking REC out of SGA, and giving REC their own new fee.
- Con: Shouldn't be put on the ballot, as students do not have the proper understanding of what the questions mean.
- Pro: less work for the senate, given that the ballot explains in depth what the questions entails
